PHS Board of Trustees Minutes March 24, 2020

Due to the COVID-19 shutdown, there was no regular meeting of the Board in March of 2020. The following reports were submitted electronically.

The museum, as well as all programs, are closed/cancelled through at least April and perhaps longer.

Treasurer's Report. Linda Wiener

Treasurer's report for February 2020 is:

Balance sheet – Total assets and equity = \$148,542. Total cash of \$50,597 (decrease of \$2,222 from January and an increase of \$4,763 from PY cash).

Profit and Loss for month: net loss of \$2,220 versus a net profit of \$1,672 in January 2020. YTD net income is \$8,758.

Profit and Loss actual compared to budget: Year-to-date through August 31, 2020

Income \$22,980 compared to \$27,345 budgeted for 2019-2020 (84% of budgeted amount)

Expenses \$16,471 compared to \$21,673 budgeted for 2019-2020 (76% of budgeted amount)

• Money transferred from CD earmarked for Community Fund is sitting in the bank until the markets stabilize.
