# Treasurer's Report. Linda Wiener

Treasurer Linda Wiener submitted her written report as follows:

May 31, 2013 treasurer report highlights:

For fiscal year September 1, 2012 - May 31, 2013, shows the following: (1) balance sheet shows total assets and equity of \$103,696 as of May 31 30, 2013, up \$2,387 from April; (2) profit and loss for 09/1/2012 - 5/31/13 is a net loss of \$506, as compared to a net loss of \$3,525 in April 2013; (3) total year to date income compared to budget total income projected for year was \$11,505 v. \$8,880 or + 30%, (4) total year to date expense compared to budget total expense projected for year was \$12,011 v. 10,011 or +20%.

#### New Business.

**Window Wells.** Recent rain storms have resulted in basement flooding. One of the culprits is the window wells which fill up with water and then leak into the basement. Possible solutions: buy or build window covers of wood and/or fiberglass, estimated cost 2,000 - 3,000; and/or possible grading away from building. Requires further investigation and report at next Board meeting.

**2013-14 Budget.** Proposed budget has a deficit. Discussion for closing the deficit centered on (1) increasing fund raising (see below), (2) reducing expenses, (3) cutting the scholarship from \$2,000 to \$1,000, and (4) having each Board member contribute to close the deficit. Further discussion to be held at August Board meeting.

Next regular meeting of the PHS Board of Trustees is on **Tuesday, August 27, 2013, at 7:00 PM, at the Museum.** Main topics to be covered are: 2013-14 budget, and fund raising. Each member is requested to submit at least one fund raising idea to Vicki by July 31.
